



SURVEY ON THE RULES GOVERNING `POLITICAL ACTIVITIES` FOR REGISTERED CHARITIES

INTRODUCTION

PLEASE NOTE, THAT WHILE MOST OF THE QUESTIONS IN HERE ARE FOR REGISTERED CHARITIES, THERE ARE SOME SPECIFIC TO NOT-FOR-PROFITS.

The Canada Revenue Agency (CRA) recently <u>launched a national consultation</u> by registered charities, inviting charities and the public to provide feedback and comments in order to clarify these rules. The consultation process will also include in-person meetings in major cities across the country starting in late November (<u>click here for more info on the consultations</u>).

The Canadian Council for International Co-operation (CCIC) and the Inter Council Network (ICN) are planning to make written submissions to the process, as are some individual provincial and regional councils. We also plan to participate and support our members' participation in the in-person meetings with CRA.

Accordingly, we have designed a joint survey to collect information from our combined memberships to inform the process. Your input is essential to inform our contributions to the consultation. The data collected will also prepare the ground for the more comprehensive modernization process that the Government has committed to undertake of the charities regulatory and legal framework.

Our collective work on the CRA file could determine what regulatory regime we will work within for the coming half a century. Please take the time to complete this survey **by Wednesday November 2**. We estimate that you will be able to complete the survey in about 15-30 minutes, depending on the nature of your organization.

The survey has been designed for *both charities that report political activities to CRA and charities or not-for-profits that do not.* You will be prompted to respond to specific questions in the survey depending on how you identify your organization.

CONFIDENTIALITY

Individual surveys and their results WILL BE TREATED AS CONFIDENTIAL by CCIC and the ICN. We understand that CRA and political activity-related information is very sensitive for many organizations. Identifying information will thus be kept confidential by CCIC and the ICN





– the sole parties that are privy to that information. While we will share and use the aggregate results and general trends in our respective CRA submissions, any data shared publicly will not identify individual organizations. All comments, inputs, or reflections will be treated anonymously.

CCIC and ICN are collaborating with Prof. John Cameron, from Dalhousie University, on the design of the survey and analysis of the data. He may also use the aggregated data in future research, however he, or other researchers, will not have access to the identifying information you provide us.

CRA RULES ON POLITICAL ACTIVITIES AND INTERNATIONAL DEVELOPMENT

- CRA has stated that "Charities play a critical role in our society. They make a valuable contribution to public policy and public debate for all Canadians. To help charities continue this important work, they must be assured they are operating in a regulatory environment that respects and encourages their contribution."
