MESSAGE FROM THE PRESIDENT & EXECUTIVE DIRECTOR

In what has been a tremendously challenging year for the international cooperation sector, OCIC has continued to grow and learn as an organization and as a community.

Significant areas of work within the Council have included the launch of a new strategic plan; completion and funding of an ambitious three-year CIDA proposal that includes OCIC's own sector strengthening and public engagement program (PE), as well as a new Inter-Council Network* (ICN) national capacity building and PE research project OCIC is now positioned to help facilitate; and maintaining our ongoing communications, networking and capacity building activities familiar to members and highlighted throughout this Annual Report.

Notably, as increased uncertainty over funding and a new competitive reality for Canadian international development organizations dominated our collective landscape this year, OCIC staff, Board Directors and members came together to share experience and perspectives on proposal writing, and took risks to voice our concerns and raise the implications of sudden change on the world's most vulnerable, with key decision makers.

Change is, of course, inevitable. Our experience this year has shown us that when its winds come in ways unanticipated, we are challenged individually and as a collective to know how best to navigate new terrain. At the same time, we have witnessed individual and collective commitment to continue working together toward our common vision of global social justice, human

dignity and participation for all, and to securing an enabling environment that supports these aspirations.

In the months ahead we challenge ourselves to become increasingly accessible to interested communities and individuals across the province, and to explore means of diversifying our revenue in ways that are principled and will help secure our future sustainability.

Thank you to all who have contributed to the Council this year. By coming together and working in solidarity we continue to build and strengthen the international cooperation sector in Ontario.

OCIC convenes a variety of networking, capacity-building and public engagement activities that support members and help Canadians develop awareness and understanding of global development issues, some of which are described below.

As a Council our priorities are to amplify the voices of the most marginalized, and to utilize inclusive, cooperative and participatory processes that are accessible and accountable to all.

Breakfast Meetings

With the combined will to share particular knowledge by members and friends of the Council, organizational support of OCIC staff, and contributions of accessible meeting space and food by larger member organizations, a range of practitioners and interested public gathered over five early morning breakfasts this year to network and share expertise towards: Realizing the UN Declaration on the Rights of Indigenous People; Youth Empowerment and Youth-led Projects in Colombia and Senegal; Political Activities for Canadian International Development Charities: Some Legal and Ethical Perspectives; NGO and the Private Sector Partnership: CUSO-VSO and Accenture in Zanzibar; and NGOs and the UN: an Odd Couple?





(Net)working Groups

OCIC Fundraising, HIV and AIDS, Internship/Volunteer-sending and Public Engagement (Net)working Groups met on regular or ad hoc basis throughout the year to convene practitioners to share challenges, approaches and good practices within each of the four thematic areas. Overall, the networking and capacity building opportunities provided in these forums were highly praised and appreciated by those able to participate, especially for helping to reduce individual workloads, and for fostering a sense of community and larger purpose within each area of work. Thank you Chairs - this could not happen without you!

Membership

Membership in the Council has continued to grow at a healthy rate this year, with a 2% increase in the overall number of organizational members (55), and 22% increase in the number of associate members (54). In addition to reviewing all applications and making recommendations for approval to our Board of Directors, the OCIC Membership Committee has also developed a new institutional membership category, through which we hope to increase our reach to new communities of relevance. Public Engagement Hub

Through the support and leadership of Michael Stephens, this year the Manitoba, Quebec and Ontario Councils for International Cooperation joined the Canadian Council in jointly administering the PE Hub -- a dynamic, bilingual, online space for the sharing of information, good practices and capacity-building resources between staff, Board and key volunteers of international development organizations working in PE, communications and fundraising in Canada.

In an effort to encourage awareness of and participation on the PE Hub, the administrative team organized and delivered 10 webinars on a range of topics. A few of these included: Fair Trade in You r Province: Principles, Promotion, and Procurement; Engaging Inner-City and Diaspora Youth; SCIC's Global Poverty Survey; using technology to support teachers and students on World Class; and legal and ethical issues for Canadian international development charities undertaking political activities.

OCIC launched the PE Hub to our members last fall as a new benefit of membership. There are currently 437 PE Hub members across the country, 122 of whom are registered to receive the Daily Digest - email updates on recent postings.

Development Drinks

This monthly event for those working or interested in the international development sector is one of OCIC's networking success stories of the year! Launched in March 2010, over the past year Development Drinks has brought together over 600 people in Toronto and Ottawa, at 16 events. Sometimes with a structured program, sometimes without, this event is always about bringing people together in an informal setting to build relationships. Capacity Building



Global Citizens Forum 2010

Tools, Tactics and Emerging Themes in Global Cooperation

October 14-15, 2010, 94 participants from across Ontario and around the world came together to participate in a series of 18 workshops and presentations that comprised our GCF 2010. Highlights included the participation of international delegates Pierre Richard Pierre from Productive Cooperatives Haiti (pcH), a partner organization of Foundation for International Development Assistance (FIDA), and Rosa Valle from CRIPDES, a partner of SalvAide; and a keynote address by journalist and political analyst Gerald Caplan.

Notable amongst sessions organized along "Overseas Operations", "Organizational & Human Resource Development", and "Reaching the Canadian Public" tracks were those on The Military and its Role in Humanitarian and Reconstruction Operations; Reducing Compassion Fatigue, Burnout and Post Traumatic Stress Disorder in Development Workers; and a Human Rights-based Approach to Development.

Principles of Financial Management Workshop

Through case studies and small group work, 15 participants in this two-day OCIC workshop with Eric Plato gained a better understanding of financial management and financial control.









Particular areas of learning included approaches to budgeting, budgeting for overhead costs, financial reports and monitoring, cash flow management, risk management and social accounting.

Personal Security Workshop

This two-day OCIC workshop aimed at enhancing the ability of staff, interns, volunteers and partners of NGOs to perform their role safely and effectively in the field. Facilitator Jeff Eames brought to its 10 participants the Interaction and worldwide standard approach to managing risks, with special emphasis on security within the development and humanitarian sectors. Particular areas of learning included contingency planning, vehicle travel, urban insecurity, incident reporting and incident analysis, abduction, stress management, defusing anger, sexual violence, and acceptance strategy.

Governance Workshop: An Overview for Not For Profit Boards

In this half-day OCIC workshop MAS facilitator Chris Govern provided an overview of the five core governance functions every Board must fulfill, how Boards carry out these functions, and how effective Boards behave. The 14 participants raised a number of questions and challenges, and shared perspectives on how to take their learnings back to their individual organizations.

Diaspora Youth Speak

Through mural painting, photography, video and spoken word, youth worker Darren Brown and 18 inner-city youth from St. Alban's Boys and Girls Club joined OCIC staff and guest facilitators weekly throughout July and August to build skills in arts and media, and explore personal, local and global social issues of interest to the participants. In the fall, reflections on engaging innercity and Diasporic youth were presented nationally in a lunch-time webinar for PE practitioners.









The partnership approach to DYS pursued with St. Albans this year built on OCIC's efforts to address the gap in participation of Diasporic communities from the global South within the international cooperation sector in Ontario in the previous two years of the project. It also helped facilitate a lasting relationship with Darren as an entry point to youth workers and inner-city youth in Toronto, and to encourage contributions from youth engaged with St. Albans programming to iAM e-Magazine.

International Development Week

From February 6-12, 2011, OCIC undertook an online and print media campaign designed to increase public awareness of the role of young Canadians in addressing global issues.

"Local heros making a global difference" nominated by OCIC members and selected by a broad-based jury included: Sarah-Leanne Deslippe, Shailyn Drukis, Manar Hossain, Justin Reid, Jamie Rooney, Tahirah Stanley, Yvonne Su, and Zeeshan Vazeer.

Other IDW activities coordinated by the Council included a lunch and learn presentation on Images in the Field: Creating Videos & Photographs in a Development Context with OCIC intern and photographer Anice Wong, and a special Development Drinks event hosted by CESO PE Coordinator Michael Paskewitz, with speakers Mike Garrett and Shailyn Drukis.

Ideas. Actions. Movements. Perspectives on Global Change.

In Volume 2 of iAM e-Magazine, OCIC's annual multimedia publication, contributors were invited to speak to some of the main issues confronting those working for positive global change today: how theory and action intersect, how to put reflection into practice, and how to bring marginalized voices to the fore.

Kaleidoscope Real World Video Challenge

This year OCIC invited youth to raise their voices on global issues by participating in the 2nd Kaleidoscope Real World Video Challenge, organized by the ICN. Seventy-nine young Ontarians participated in OCIC video workshops or responded independently to the call, submitting 23 videos on issues as diverse as water pollution and environmental degradation, to stereotyping and stigma, bullying at school, and urban poverty.

Ontario participants came together to view a selection of the best films at an OCIC gala at the National Film Board of Canada, in early May. Of the ten videos selected by a provincial jury and recognized at the event, "Fresh Water" by Mary Paquet from Canterbury High School in Ottawa, and "The Fabulous Composters 1" by Mr. Carkner's grade three class at Crescent Town Elementary School in Toronto, won top awards!

Voicing Member Interests

Responsive Member Meetings

OCIC staff worked closely with Board Directors to convene members in a range of ways to better understand the new funding mechanisms at CIDA's Partnerships with Canadians Branch (PWCB) this year. Through conference call discussions, member peer learning sessions, a provincial funding survey, a member meeting with Darren Schemmer, Vice-President PWCB, and ongoing communications with CIDA officials, we have been able to gather and provide focused feedback to the Agency, while supporting members own work. We look forward to playing an ongoing role in this area, in the year ahead.

Inter-Council Network

The Inter-Council Network (ICN) - comprised of the Alberta, Atlantic, British Columbia, Manitoba, Ontario, Quebec and Saskatchewan Councils for International Cooperation - came together in a number of ways to share experience, build collective capacity, represent member interests, and engage the Canadian public on global social issues.

Key accomplishments of our joint efforts included the completion of a PE Position Paper that has subsequently been presented or utilized by several of the Councils and our members in various fora; ongoing meetings to share the experiences and concerns of our members over sector-wide changes

affecting the community; and development and delivery of the 2nd Kaleidoscope Real World Video Challenge.

The ICN was also hard at work on the completion of a joint three-year CIDA proposal that will allow us to deliver capacity building opportunities for our collective membership, and to undertake a PE research and capacity building initiative that builds on the recommendations in our PE Position Paper. Elements of the latter will include: a national public opinion poll on global poverty issues: a literature review of academic research on PE leading to active global citizenship; "mapping" of PE activities and approaches being undertaken within and beyond the international development sector across Canada: formation and facilitation of topic-focused "Knowledge Hubs" to distill and share good practices in PE; and development and delivery of a tool kit, training module and national conference to disseminate learnings, broadly.

OCIC is honoured to have been selected as the "host" of the ICN initiative for the next three year period. We look forward to this special role, and to helping to shape the collaborative work to come.

OCIC DEVELOPMENT PRINCIPLES

The Council recognizes that global justice requires the transformation of social structures and changes in human relations to reflect the following principles:

Human Rights & Basic Human Needs

- Every human being has the right to her/ his basic human needs: adequate food, clean water, housing, health care, education, and employment.
- 2. Equal civil, political, economic, social, and cultural rights for all humankind are the foundation for freedom, justice, and peace in the world.
- 3. Given the connection of racism to historical and contemporary forms of economic exploitation, all forms of oppression and discrimination of peoples and individuals based on race and colour must be eliminated.

- 4. Development requires the elimination of all forms of inequality, work performed, exploitation, and discrimination of peoples and individuals based on factors including national origin, ethnicity, religion, language, class, gender, sexual orientation, disability, and age.
- 5. We believe in a development process which respects cultures and local realities, and affirms the Universal Declaration of Human Rights.
- 6. Development must be redefined, placing the development of civil society at its centre, with economic, political and social systems serving basic human needs.

Global Resource Stewardship

- 7. Redistribution of the world's resources should meet basic human needs everywhere.
- 8. Resources must be controlled locally to serve the needs of local populations in an equitable manner.

9. Global production and consumption levels must be addressed in the development process. Disproportionate consumption levels in the North lead to a systemic lack of resources to fulfill basic human needs in the South

Democratic Societies & Governance
10. Participatory, cooperative and inclusive processes are vital in the struggle for development and global justice. Political and public office positions must be accessible to all citizens and those in positions of power must be fully accountable.

11. Global justice requires equal participation of women and men in political and economic decision making. The historical power imbalance between women and men must be addressed through analyses of structural inequities with concrete strategies/practices to guarantee equal access to power, wealth, and resources, and fair compensation for work performed.


12. Global justice respects the right of indigenous peoples to self-determination, self-government, and to territorial claims, including the resources within their territories.

13. Conflicts require peaceful solutions.
Resources allocated for arms production
and export must be redirected towards the
fulfillment of basic human needs.

Mandate

14. OCIC shall encourage the development and sharing of resources for participatory global education in the province of Ontario by facilitating networking and capacity building within its membership.

15. OCIC is committed to being a learning and democratic organization with inclusive cooperative and participatory processes that are accessible and accountable to all members.
